DELIVERING SOCIAL VALUE

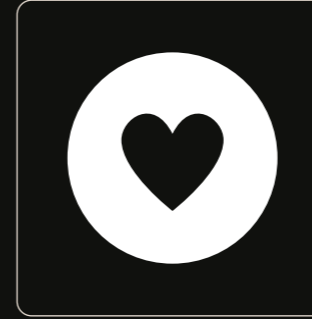
WE COMPLETED A SOCIAL VALUE BASELINE ASSESSMENT OF GLOUCESTER QUAYS TO UNDERSTAND OUR IMPACT ON THE COMMUNITY.

THE ASSESSMENT INCLUDES AN INVESTIGATION INTO THE SOCIAL AND ECONOMIC CHARACTERISTICS OF THE LOCAL AREA AS WELL AS A REVIEW OF THE LOCAL POLICIES AND STRATEGIES TO IDENTIFY THE SOCIAL THEMES THAT WE CAN BEST SUPPORT THROUGH OUR ACTIONS.

WE ALSO ANALYSED DATASETS FOR POPULATION DEMOGRAPHICS, EDUCATION, EMPLOYMENT, DEPRIVATION, HEALTH & WELLBEING AND ACCESS TO GREEN SPACE.

USING THIS BACKGROUND INFORMATION, WE ESTABLISHED A 2KM RADIUS AROUND GLOUCESTER QUAYS AND USED IT TO DEFINE A LOCAL IMPACT AREA (LIA) WHERE WE CAN MEASURE MOST OF THE VALUE DELIVERED BY THE ASSET.
